BSN ADMISSION REQUIREMENTS

Admission to the nursing program is competitive. Applicants must be academically and psychologically prepared for admission. The number of students enrolled in clinical nursing courses is limited by the availability of clinical facilities, the number of faculty, and any relevant regulation established by the West Virginia Board of Examiners for Registered Professional Nurses.

Applicants who are recent high school graduates must meet the following requirements in addition to the college entrance requirements:

- Cumulative GPA of 3.0
- Completion of 8 credits of Anatomy and Physiology with a grade of at least a "C";
- Completion of the ATI Admission Assessment Exam with a minimum composite score of 64% taken in the summer
- Completion of the Assessment Technologies Institute, Inc. ® (ATI) Test of Essential Academic Skills (TEAS) with a minimum composite score of 64%. Students may only take the exam two times per academic year. The academic year is defined as fall/spring/summer. Students have a maximum of two academic years at D&E to complete all the requirements. Therefore, a student has a maximum of 4 attempts on the TEAS test to achieve a 64% or higher;
- Students who initially do not meet the requirements for admission to the nursing program may elect to be "pre-nursing" while they are attempting to meet requirements. If requirements are not fully met after a maximum of 2 academic years at D&E with completion of all requirements prior to August 1, the student will not be considered for admission to the nursing program; and
- The maximum number of students accepted into the nursing program is limited by the West Virginia Board of Examiners for Registered Professional Nurses.
